This Application may collect some Personal Data from its Users.

Summary:

Personal Data may be collected for the use of the following services:

As the RSF App provides direct access to the RSF third-party pages on Apps listed below, tracking may occur to determine frequency of third-party app access via the RSF App, so RSF can determine what features are valuable to our customers. Access to third party services' accounts for purposes allowing your account to be logged into from the RSF App for the following third party services:

- Access to the Facebook account
- Access to the Instagram account
- Access to the LinkedIn account
- Access to the YouTube account

*** RSF will NOT track your posts/likes/comments or keystrokes on these third-party sites.

- Interaction with external social networks and platforms (traffic using these sites through RSF App)
- Personal Data: Cookies, Usage Data, Feed Portal Profile information

This App uses Google Analytics services to learn what parts of the RSF App are being used the most. This is collected so that we can include and exclude features to have the App to offer what our users most want included.

Data Controller and Owner

Types of Data collected

Among the types of Personal Data that this Application collects, by itself or through third parties, there are:

Cookie and Usage Data.

Other Personal Data collected may be described in other sections of this privacy policy or by dedicated explanation text contextually with the Data collection.

The Personal Data may be freely provided by the User, or collected automatically when using this Application.

Any use of Cookies - or of other tracking tools - by this Application or by the owners of third-party services used by this Application, unless stated otherwise, serves to identify Users and remember their preferences, for the sole purpose of providing the service required by the User.

Failure to provide certain Personal Data may make it impossible for this Application to provide its services.

The User assumes responsibility for the Personal Data of third parties published or shared through this Application and declares to have the right to communicate or broadcast them, thus relieving the Data Controller of all responsibility.

Mode and place of processing the Data

Methods of processing

The Data Controller processes the Data of Users in a proper manner and shall take appropriate security measures to prevent unauthorized access, disclosure, modification, or unauthorized destruction of the Data. The Data processing is carried out using computers and/or IT enabled tools, following organizational procedures and modes strictly related to the purposes indicated. In addition to the Data Controller, in some cases, the Data may be accessible to certain types of persons in charge, involved with the operation of the site (administration, sales, marketing, legal, system administration) or external parties (such as third-party technical service providers, mail carriers, hosting providers, IT companies, communications agencies) appointed, if necessary, as Data Processors by the Owner. Information from the use of our Applications

When you use our mobile apps, we may collect certain information in addition to information described elsewhere in this Policy. For example, we may collect information about the type of device and operating system you use. We may ask you if you want to receive push notifications about activity in your account. If you have opted in to these notifications and no longer want to receive them, you may turn them off through your operating system. We may ask for, access or track location-based information from your mobile device so that you can test location-based features offered by the Services or to receive targeted push notifications based on your location. User
